Project Description: **Revision to grading permit GRDE15-0004. That permit was issued to Raging River Mining for operation of a hard rock quarry on 17 acres. The new application is to expand the area available for extraction by an additional 25.83 acres less setbacks and buffers. The proposed area of expansion includes parcel no. 2224079033. This area underwent a rezone process from FR (Forest Recreation) potential QM (Quarry Mining) to Quarry Mining in 1987. The designation was subsequently changed to M (Mining) through a county wide comprehensive plan change in 1995.**
